June 1st, 2020 - source shaw et al 2004 mental illness in people who kill strangers longitudinal study and national clinical survey bmj with regards to mental health and violence the study found that only 5 of stranger murders carried out between 1996 1999 were committed by people diagnosed with schizophrenia with the most common diagnosis for those committing these crimes being personality'

June 2nd, 2020 - in many countries there continue to be conflicting opinions and mechanisms regarding the appropriateness of treatment and or punishment for mentally ill individuals who commit crimes the general population is concerned with public safety and often finds it difficult to accept the possibility that a mentally ill individual who commits a crime can be hospitalized and eventually discharged

May 14th, 2015 - as a result 2 million people with mental illness are booked into jails each year nearly 15 of men and 30 of women booked into jails have a serious mental health condition the vast majority of the individuals are not violent criminals most people in jails are have not yet gone to trial so they are not yet convicted of a crime'
